This includes strategies such as redacting board material and board members leaving the room when conflicts arise, so they are not included in the discussion and decision-making process.

This 'Public-facing Conflict of Interest Register' is published with consent of the Board members. It is a live document, and it will be updated as new conflicts arise or as conflicts are closed and reviewed after each Board meeting.
